### WORDS TO KNOW

#### Content controls

Tools used to create forms.

#### Form

A document used to collect and organize information.

#### Macro

A series of instructions designed to accomplish a particular task that you can launch with a single command.

**Software Skills** Use forms to collect information such as names and addresses for product registrations, data for surveys, or products and pricing for invoices or purchase orders. With Word, you can create forms that can be printed and filled out manually. You can also store forms on a computer so they can be filled out onscreen. Create a macro to automate a process such as inserting text or applying formatting.

## What You Can Do

---

### Inserting Content Controls

- Insert **content controls** in a document to create a **form** for collecting information that can be stored and analyzed.
- For example, a human resources department might use a form to collect and store employee information.
- Use the buttons in the Controls group on the Developer tab of the ribbon to insert content controls.
- The Developer tab does not display by default; you must set an option to make it available.
- Available content controls include:
  - Rich Text
  - Plain Text
  - Picture
  - Building Block Gallery
  - Check Box
  - Combo Box
  - Drop-Down List
  - Date Picker

- Instructional text automatically displays in each content control that you insert.
  - For example, if you insert a Text control, it displays *Click or tap here to enter text*. If you enter a Drop-Down List control, it displays *Choose an item*.
  - For best results, create a form as a document template; you can then use the template to create new form documents as you need them.
  - Users can also print the document and fill out the form on paper.
  - When inserting content controls, give some consideration to the form layout. You may want to use a table or tab stops to be sure items are aligned so that it will be easy for users to read and fill out the form.
- Also, it is important to keep in mind that the insertion point moves from control to control based on the order in which controls are inserted in the document, not based on the order in which the controls are arranged.
  - Versions of Word prior to Word 97 do not support content controls. If you know a form will be used on a system running an older version of the program, you can use Word's Legacy Tools to insert form fields instead of content controls.

**Try It!****Inserting Content Controls**

- 1 In Word, open **W28Try** from the data files for this lesson.
- 2 Save the file as a Word template (\*.dotx) with the name **W28TryA\_xx** in the location where your teacher instructs you to store the files for this lesson.
- 3 Click File > Options > Customize Ribbon.
- 4 Under Customize the Ribbon, click to select the Developer check box, and then click OK.
- 5 In the document template, click to position the insertion point in the table cell in the first row of the right column.
  - ✓ *If table gridlines are not displayed, click to the right of the text Name:, click the Table Tools Layout tab, and click to toggle on the View Gridlines button .*
- 6 Click the Developer tab on the ribbon, then, in the Controls group click the Rich Text Content Control button **Aa**.
- 7 Position the insertion point in the cell in the second row of the right column, then click the Drop-Down List Content Control button .
- 8 Move the insertion point down one cell and click the Date Picker Content Control button .
- 9 Position the insertion point in the second cell in the bottom row and click the Check Box Content Control button .
- 10 Position the insertion point in the cell on the right end of the bottom row and click the Check Box Content Control button .
- 11 Save the changes to the document template, and leave it open to use in the next Try It.

## Setting Content Control Properties

- By default, Word inserts content controls using basic settings. For example, text controls are set to allow users to enter an unlimited number of text characters.
- You can customize the content control options in the item's Properties dialog box.
- For example, you can set text options to limit users to entering valid dates, or no more than ten characters, and you can assign a style to text entered in a plain text content control.
- You can also change the instructional text that displays in a content control.
- Each type of content control has its own set of properties. For example, you use properties to enter the items for a Drop-Down List content control.

### Try It!

### Setting Control Content Properties

- 1 In the **W28TryA\_xx** file, click on the Rich Text content control in the table to select it.
- 2 On the Developer tab, in the Controls group, click the Properties button  to display the Content Control Properties dialog box.
- 3 In the Title box, type **Name**, and then click OK.
- 4 Click the Drop-Down List content control to select it, and click the Properties button.
  - ✓ *Notice that the properties for the Drop-Down List content control are different from the properties for the Rich Text content control.*
- 5 In the Title box, type **Department**.
- 6 Under Drop-Down List Properties, click the Add button to display the Add Choice dialog box.
- 7 In the Display Name box, type **Marketing**, and then click OK.
- 8 Click the Add button again, type **Sales**, and click OK.
- 9 Click the Add button again, type **Site Support Group**, and click OK.
- 10 In the Content Control Properties dialog box, click OK.
- 11 Save the changes to **W28TryA\_xx**, and leave it open to use in the next Try It.

## Protecting a Form

- It is a good idea to protect a form template.
- When a form is protected, users can enter information in the content controls, but cannot edit or format any other part of the document.
- The protection is extended to all documents based on the protected template.
- The options for protecting a document are found in the Restrict Editing pane, which you can access using the Restrict Editing button on the Developer tab of the ribbon.
  - ✓ *You learn about other ways of protecting documents in Word, Lesson 29.*
- You must stop the protection in order to edit or format the form.

### Try It!

### Protecting a Form

- 1 In the **W28TryA\_xx** file, on the Developer tab in the Protect group, click the Restrict Editing button  to display the Restrict Editing pane.
- 2 In the task pane under Editing restrictions, click to select the Allow only this type of editing in the document check box.
- 3 Click the drop-down arrow and click Filling in forms.
- 4 Click Yes, Start Enforcing Protection, and in the Start Enforcing Protection dialog box, click OK.
- 5 Try to select the text *Name*:. Note that Word only allows you to select content controls.

**Try It!****Protecting a Form (continued)**

- 6 In the Restrict Editing pane, click Stop Protection. Now, you can edit or format the document.
- 7 In the Restrict Editing pane, click Yes, Start Enforcing Protection, and in the Start Enforcing Protection dialog box, click OK.
- 8 Close the **W28TryA\_xx** file, saving changes. Leave Word open to use in the next Try It.

**Filling Out a Form**

- To fill out a form manually, simply print it.
- To fill out a form onscreen, create a new document based on the form template.
- If the form is protected, Word automatically selects the first content control so you can begin filling it out.
- If necessary, click to select a different content control.
- You can leave content controls blank.
- Use the methods shown in Table 28-1 to enter data in content controls.

**Table 28-1****Entering Data into a Content Control**

Content Control Type	How to Enter Data
Rich Text	Type
Plain Text	Type
Drop-down list	Click drop-down arrow and click item to enter
Date picker	Click drop-down arrow and click date to enter
Building block gallery	Click drop-down arrow on control's handle, then click item to enter
Picture	Double-click icon in control, then use the Insert Pictures dialog box to locate and select picture to insert
Check box	Click to select or clear box
Combo box	Click drop-down arrow and click item to enter

- 1 Use File Explorer to create a new document based on the **W28TryA\_xx** document template.
  - ✓ *Navigate to the location where the template file is stored, and double-click the template name.*

## Analyzing Surveys

- A survey lets you collect information that you can use to analyze trends and changes.
- Watching and analyzing trends can help managers make informed business decisions.
- For example, retailers watch for trends in the colors and products customers are buying so they know what items to stock in stores.
- A well-designed survey makes it easier to identify trends. It usually includes a plan for whom to survey and the questions to ask, as well as a form for entering the answers to the survey questions.

## Working with Macros

- To efficiently complete repetitive tasks, such as performing identical formatting chores in a number of documents, you can create a **macro**.
- A macro gathers a number of instructions into a single program that you can run with a single command.
- You create a macro by executing the steps you want to capture. Then you end the macro, storing it so that it can be used again.
- You may want to rehearse the steps you will use to create the macro before recording it because some tasks have to be done in a certain way during the recording process. You cannot use the mouse to select text, for example. Instead, you must use a keyboard combination to select text.

- When you start the process of creating a new macro, you assign it a name, choose a shortcut option for running the macro, and choose whether to store it in the current document or in the Normal template so it will be available for all documents based on that template.
- If you choose to store the macro in the current document, you must then save the document in the Word Macro-Enabled Document (\*.docm) format. Trying to save the document as a regular Word document will result in Word's discarding the macro after you close the document.
- Word macros can be used to perform malicious tasks and it is thus important to consider security issues when creating and sharing documents with macros. One way that Word helps you manage macro security is to disable macros by default even when they are saved in Word Macro-Enabled Document format.
- When you open a document in which a macro has been stored, you will see the security warning banner at the top of the document. Click Enable Content to allow the document's macros to be run.
- Run a macro by choosing it in the Macros dialog box, by clicking a button you create, or by pressing a key combination you assign.

### Try It!

### Working with Macros

- 1 In Word, create a new blank document and save it in Word Macro-Enabled Document format as **W28TryC\_xx** in the location where your teacher instructs you to store the files for this lesson.
- 2 On the View tab, in the Macros group, click the Macros arrow  and then click Record Macro.
- 3 In the Record Macro dialog box, type **MyName** to replace the default Macro1 name.
- 4 Click the Store macro in down arrow and select **W28TryC\_xx**.
- 5 Click Keyboard to open the Customize Keyboard dialog box.
- 6 Click in the Press new shortcut key box and then press **ALT + 0** (the second key is zero).
- 7 Click the Save changes in down arrow and select **W28TryC\_xx**.
- 8 Click Assign and then click Close. The pointer changes to the Record Macro pointer .
- 9 On the first line of the document, type your first and last name.
- 10 Press **CTRL + SHIFT + F5** two times to select both names.

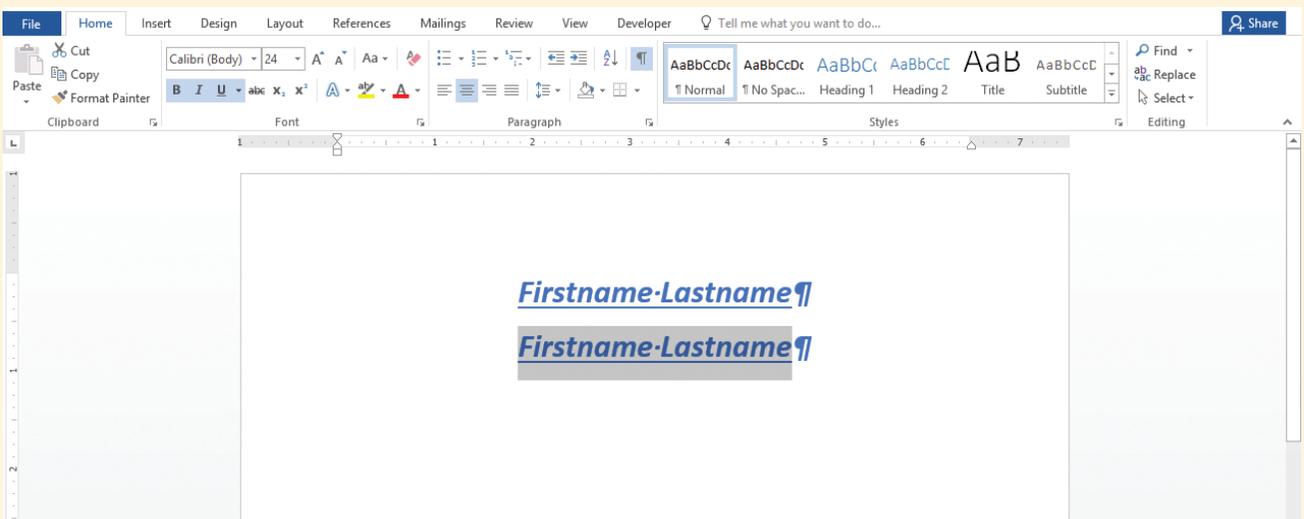

- 11 Click Home > Center.
- 12 Click Home > Font dialog box launcher  to open the Font dialog box.
- 13 In the Font style list, click Bold Italic. In the Size list, scroll down and click 24. Click the Font color down arrow and select Blue, Accent 5. Click the Underline style down arrow and select a single underline.
- 14 Click OK, and then click View > Macros arrow  > Stop Recording.
- 15 Save the changes to **W28TryC\_xx**, close the document, and leave Word open for the next Try It.

**Try It!****Playing a Macro**

- 1 In Word, click File > Open, and click **W28TryC\_xx** at the top of the list of Recent Documents.
- 2 Note the security warning bar at the top of the document. Click Enable Content.
- 3 Click at the end of the first line of text, press , and then apply the Normal style to the new blank paragraph.
- 4 Press  +  to run the macro. A second instance of your name as you formatted it in the last Try It should display.
- 5 Save the changes to **W28TryC\_xx**, close the document, and exit Word.

## Lesson 28—Practice

- Select the right cell in row 5 and click **Table Tools Layout > Split Cells**  > **OK**.
- Enter the following text in your table:
- Select the table and increase the font size to **16 points**.
- If the Developer tab is not displayed on the ribbon, click **File > Options > Customize Ribbon**; then, under Customize the Ribbon, click to select the **Developer** check box, and then click **OK**.
- Click in row 1, column 2, click the **Developer** tab, then, in the Controls group, click the **Rich Text content control** button **Aa**.
- Click in row 2, column 2, and click the **Plain Text content control** button **Aa**.
- Click in row 3, column 2, and click the **Date Picker content control** button .
- Position the insertion point after the word *Yes* in row 5, column 2, press **ENTER**, and then click the **Check Box content control** button .
- Position the insertion point after the word *No* in row 5, column 3, press **ENTER**, and then click the **Check Box content control** button .
- Click in row 6, column 2, and then click the **Drop-Down List content control** button .
- With the Drop-Down List Content Control selected, click the **Properties** button .
- Under Drop-Down List Properties, click the **Add** button, type **Too difficult**, and click **OK**.

20. Click the **Add** button again, type **Too easy**, and click **OK**.
21. Click the **Add** button again, type **Not what I expected**, and click **OK**.
22. In the Content Control Properties dialog box, click **OK**.
23. Check and correct the spelling and grammar in the file, and then save the changes.
24. Click the **Developer** tab, and then click the **Restrict Editing** button .
25. In the Restrict Editing pane, under Editing restrictions, click to select the **Allow only this type of editing in the document** check box, then click the drop-down arrow and click **Filling in forms**.
26. Click **Yes, Start Enforcing Protection**, and then click **OK**. Close the task pane.
27. **With your teacher's permission**, print the document. It should look similar to Figure 28-1.
28. Close the file, saving changes, and exit Word.

13. Set properties for the Drop-Down List content control to add the following items: **Live instructor, Online classroom, Individual training workstation.**
14. In row 10, column 2, insert a **Rich Text** content control.
15. Check and correct the spelling and grammar in the file, and then save the changes.
16. Protect the document so users can only fill in content controls on the form.
17. Close the task pane, and then close the document, saving changes.
18. Create a new document based on the **W28ApplyA\_xx** template and save it as a Word document with the name **W28ApplyB\_xx** in the location where your teacher instructs you to store the files for this lesson.
19. Type your name in the *Name* Plain Text content control.
20. Type **Marketing** in the *Department* Plain Text content control.
21. Select today's date from the Date Picker content control.
22. Select the **Yes** check box for whether or not you have attended in-house training classes.
23. Select the **No** check box for whether or not you were satisfied.
24. For the reason why you were not satisfied, select **Inconvenient time** from the Drop-Down List content control.
25. Select the **Maybe** check box for whether or not you are interested in future classes.
26. Select **Individual training workstation** from the training method Drop-Down List content control.
27. In the Rich Text content control, type **I think there is potential benefit to in-house training but I need a more flexible schedule.**
28. **With your teacher's permission**, print the document. It should look similar to Figure 28-2 on the next page.
29. Close the file, saving changes, and exit Word.

### WORDS TO KNOW

#### Authenticated

Checked and verified as real or legitimate.

#### Code of conduct

A policy that defines the behavior expected of all employees.

#### Confidentiality

A legal and ethical principle that prevents the disclosure of secret information to unauthorized parties.

#### Encryption

Scrambling so as to be indecipherable.

#### Ethical

Conforming to accepted standards of social or professional behavior.

#### Firewall

Software or hardware that monitors information as it passes from a network to your computer in order to detect and prohibit the transfer of malicious programs.

**Software Skills** With Word, you can restrict the ability of others to edit or format a document. You can set password protection to limit unauthorized access to a document, and you can set different levels of access to allow others to read but not edit or format a document, or to require the track changes feature to mark all edits.

## What You Can Do

### Restricting Editing and Formatting

- You can protect a document from unauthorized changes by restricting the ability of others to make edits or apply formatting.
- To restrict formatting changes, you use options in the Formatting Restrictions dialog box to limit the ability of others to modify selected styles and apply direct formatting.
- To restrict editing changes, you may select from four options:
  - Tracked changes. Use this option to force edits to display using revision marks.
  - Comments. Use this option to allow others to enter comments without being able to edit document text.
  - Filling in forms. Use this option to allow changes in content controls only.  
✓ *Protecting forms is covered in Word, Lesson 28.*
  - No changes (Read only). Use this option when you do not want to allow any changes at all.
- The options for setting restrictions are found in the Restrict Editing pane, which you can access using the Restrict Editing button on the Developer or Review tab of the ribbon.
- When you open a protected document, the Restrict Editing pane displays information about the changes you may or may not make to the document.
- You can also view information about restriction settings on the Info tab in the Backstage view.

- You can remove the protection to enable unlimited editing.
- Note that restrictions apply to documents even when they are copied or saved with a new name.

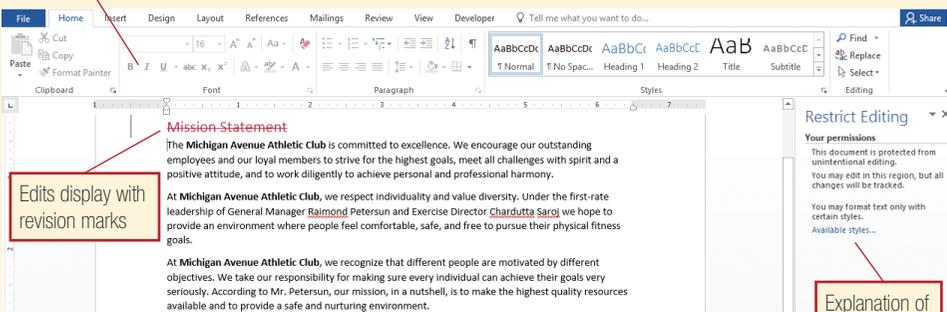

- 1 Start Word and open **W29Try** from the data files for this lesson.
- 2 Save the file as **W29Try\_xx** in the location where your teacher instructs you to store the files for this lesson.
- 3 On the Review tab, in the Protect group, click the Restrict Editing button.
- 4 In the Restrict Editing pane, under Formatting restrictions, click to select the Limit formatting to a selection of styles check box and then click Settings to display the Formatting Restrictions dialog box.
- 5 In the Formatting Restrictions dialog box, click Recommended Minimum and click OK.
- 6 If necessary, in the warning dialog box, click No.
- 7 In the Restrict Editing pane, under Editing restrictions, click to select the Allow only this type of editing in the document check box, then click the drop-down arrow and click Tracked changes.
- 8 Under Start enforcement click Yes, Start Enforcing Protection, then click OK without entering a password.
- 9 Click the Home tab on the ribbon. Note that most Font and Paragraph group commands are not available because of the formatting restrictions.
- 10 Select the heading *Mission Statement* and press **DEL**. The edit is displayed with revision marks because of the editing restrictions.
  - ✓ Click the vertical red line in the left margin to see the revision marks, if necessary.
- 11 Save the changes to **W29Try\_xx**, and leave it open to use in the next Try It.

Explanation of restrictions

**Integrity**

Adherence to a strict moral or ethical code.

**Password**

A string of characters used to authenticate the identity of a user, and to limit unauthorized access.

**Phishing**

A method of tricking computer users into divulging private or confidential information over the Internet.

**Unethical**

Not conforming to accepted standards of social or professional behavior.

**Virus**

A malicious computer program designed to cause damage to a computer system.

**Workgroup**

A team or group of individuals who work together on the same projects, usually connected via a network.

**Worm**

A self-replicating program designed to cause damage to a computer system.

## Setting Restriction Exceptions

- By default, an entire document is protected from changes made by all users.
- If you set formatting, read only, or comments restrictions, you may specify exceptions to allow access to all or parts of the document.
- Parts of the document that may be modified are set off by brackets and shading by default.
- You can use options in the Restrict Editing pane to scroll directly to the areas you have permission to change.
- You can allow access to everyone, or specific individuals or groups who have access.
- To add an individual or group to the exceptions list, you must know the **workgroup** identification, e-mail address, or Microsoft Windows user account name the he or she uses to log on to the system.

### Try It!

### Setting Restriction Exceptions

- 1 In the **W29Try\_xx** file, in the Restrict Editing pane, click Stop Protection.
- 2 Under *Editing restrictions*, click the drop-down arrow and click No changes (Read only).
- 3 In the document, right-click the heading *Mission Statement* and click Reject Deletion.
- 4 Select the heading, then press and hold **CTRL** and select the second body paragraph.
- 5 Under *Exceptions (optional)*, click to select the Everyone check box, then click Yes, Start Enforcing Protection, and click OK in the Start Enforcing Protection dialog box without entering a password.
- 6 In the first paragraph in the document, select the text *Michigan Avenue Athletic Club* and press **DEL**. Nothing happens, because restrictions are set to allow no changes.
- 7 In the second paragraph select the text *Michigan Avenue Athletic Club* and press **DEL**. The text is deleted, because everyone is allowed to edit or format the second paragraph.
- 8 In the Restrict Editing pane, click Find Next Region I Can Edit. The heading is selected.
- 9 Edit the heading from *Mission Statement* to **Club Mission Statement**.
- 10 Save the changes to **W29Try\_xx**, and leave it open to use in the next Try It.

## Applying Password Protection and Encryption

- To ensure that users cannot remove or change restriction settings, you can assign a **password** when you start enforcing protection. Only someone who enters the assigned password can unprotect the document or change the restriction settings.
- Note that the password protection applies to documents even when they are copied or saved with a new name.
- You can also assign a password and encrypt a document at the same time using options on the Info tab in the Backstage view.
- **Encryption** increases the security of the document, because only **authenticated** owners of the document can remove the protection.
  - ✓ *Authenticity is based on the use of a valid digital signature. Digital signatures are covered in Lesson 31.*
- Always create a strong password, which is one that cannot easily be guessed by unauthorized personnel.
- According to Microsoft, a strong password combines upper- and lowercase letters, numbers, and symbols, and is more than 8 characters long.
- Take care when assigning passwords. If you forget the password, you will not be able to access the document.

## Understanding Computer Ethics and Codes of Conduct

- In general, the ethics for computer use should follow the same basic code of ethics for all business and personal conduct.
- In other words, employees and employers should conduct themselves in a professional and **ethical** manner, with honesty and **integrity**, according to legal and corporate policies.
- Most companies and organizations establish corporate computer application policies or rules, as well as policies for using the Internet and e-mail.
- These policies address the legal and social aspects of computer use and are designed to protect privacy while respecting personal and corporate values and adhering to federal and local laws.

- Some topics typically covered by corporate computer application policies include:
  - The type of language allowed in documents and messages.
  - Permissions for accessing documents and data.
  - The amount of time allowed for personal Internet and e-mail use.
  - The types of Web sites that may be accessed from corporate computers.
  - Storage policies for documents and e-mail.
  - The types of programs that may be used on corporate computers.
- Most employers have a written policy called a **code of conduct** that specifies the rights and responsibilities of employees.
- The codes vary depending on the organization. Most list the types of behavior that are considered acceptable, as well as behavior that is considered unacceptable.
- Some typical expectations include:
  - Reporting **unethical** or illegal behavior in others.
  - Respecting the **confidentiality** of clients, co-workers, and employers.
  - Arriving and leaving on time.
  - Wearing professional attire in the workplace.
- Most codes also specify the consequences of failing to meet the standards.
- For a first or minor infraction, the punishment might be a warning letter placed in an employment file.
- For a severe or repeated infraction, the punishment might be dismissal.
- Accidentally knocking out a power cord might delete unsaved changes to a file.
- A thief might steal your notebook computer or external hard drive.
- Malicious software such as a **virus** or **worm** might corrupt your data.
- A **phishing** Web site might capture private information such as passwords and financial data.
- Some steps you can take to safeguard your data include saving frequently, backing up to a remote location on a regular basis, and storing backup data in a fire- and flood-proof safe.
- You should activate a **firewall** to prevent unauthorized programs from accessing your system via a network.
- You should use a malicious software detector tool, such as Windows Defender, to monitor and protect your system from malware such as worms.
- You should use a virus protection program to prohibit, detect, and remove computer viruses.
- You should also learn about the features and tools that your operating system has for preventing data loss:
  - You can use System Restore to revert to a restore point from an earlier date to undo changes.
  - You can use system recovery tools such as Startup Repair or Memory Diagnostic.
- Computer system security usually includes hardware and software devices as well as managerial procedures that work together to protect the system from unauthorized access, to make sure the data is available when needed, and to maintain the integrity of the data.
- Types of security devices include firewalls, virus detection programs, passwords, and data encryption.
- A breach in security compromises data stored on the system, resulting in lost revenues.
- In addition, there are laws governing computer security, which means businesses may be legally responsible for a breach.

## Understanding Computer Security

- Maintaining the security of computer systems is a vital part of any business.
- Many situations can put your computer information at risk.
  - Disasters such as a flood or fire might make a hard disk unusable.

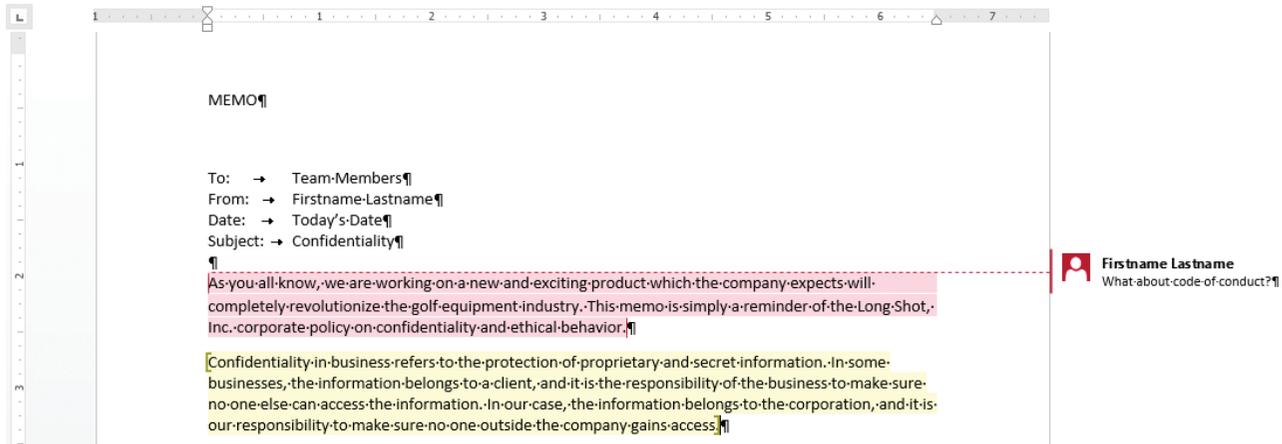

12. Check and correct the spelling and grammar in the document, and then save the changes.
13. Click the **Review** tab; then, in the Protect group, click the **Restrict Editing**  button.
14. In the Restrict Editing pane, under *Formatting restrictions*, click to select the **Limit formatting to a selection of styles** check box and then click **Settings**.
15. In the Formatting Restrictions dialog box, click **Recommended Minimum** and click **OK**.

## What You Can Do

---

### Using the Document Inspector

- Run the Document Inspector to identify information you might not want to share with other people working with your document files.
- Once you identify the content, you have the option of keeping it with the file or removing it.
- For example, you might want to delete comments before passing a file on to another reviewer, or remove document properties that might include personal or confidential information.
- When you start the Document Inspector, you can select to check for the following types of information:
  - Comments, Revisions, Versions, and Annotations
  - Document Properties and Personal Information
  - Task Pane Apps
  - Collapsed Headings
  - Custom XML Data
  - Headers, Footers, and Watermarks
  - **Invisible Content**
  - **Hidden Text**
- After you remove document properties, they will no longer automatically be saved with the file.
- You can choose to save document properties again by clicking **Allow this information to be saved** in your file on the Info tab in the Backstage view.

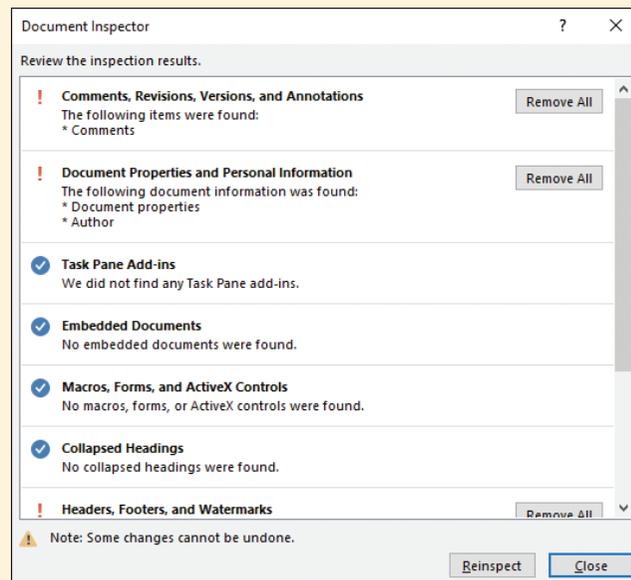

## Checking Compatibility

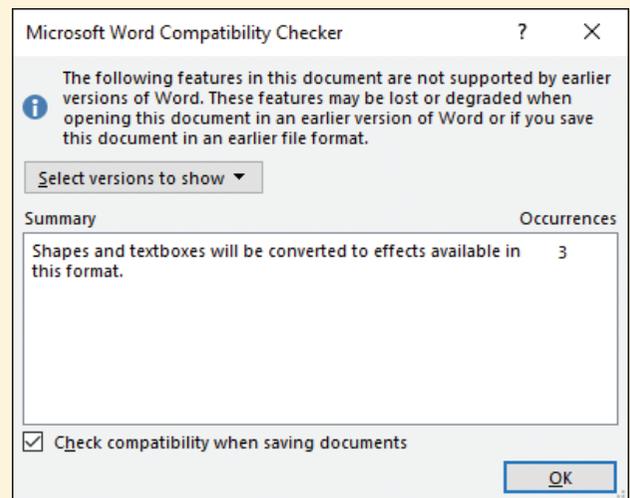
- You can check your Word 2016 documents for **compatibility** to identify features that might not be supported by earlier versions of Word, such as content controls.
- By default, the Compatibility Checker feature runs automatically when you use the Save As command to save a document in Word 97-2003 format.
- After checking the document, Word displays a summary list of incompatible features.
- The summary list includes the number of times the feature is used and explains the action Word 2016 will take to resolve the incompatibility issue when the document is saved in an earlier format.
- The changes are made only in the documents saved in Word 97-2003 format; the original Word 2016 documents remain unchanged.
- You can also start the check from the Check for Issues drop-down menu in the Inspect Document area on the Info tab in the Backstage view.
- Use Word Help to view a table listing Word 2016 features that are not available in Word 97-2003, Word 2007, Word 2010, or Word 2013. Start Help, search for compatibility, and click the link to Compatibility changes between versions.
- You can also check your Word 2016 documents for possible accessibility issues, to identify content that those with disabilities might find difficult to read. To do so, click File > Check for Issues > Check Accessibility.

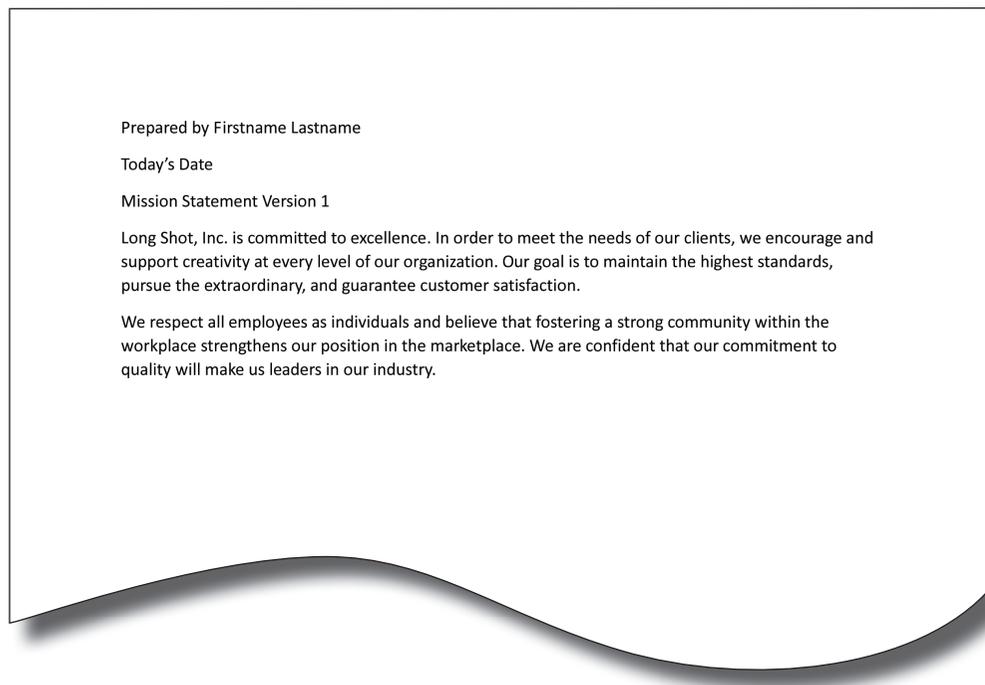

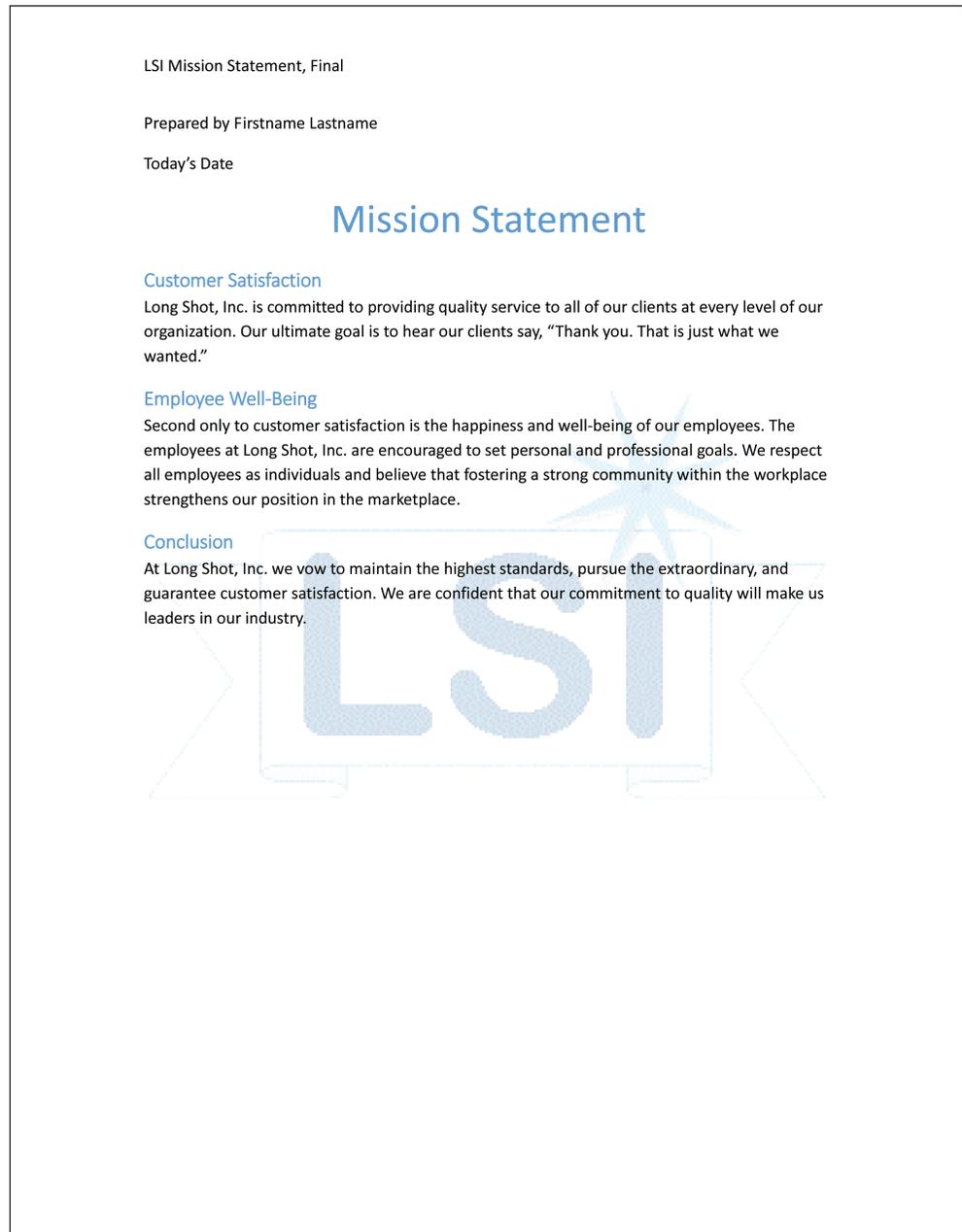

**Software Skills** Use a visible or invisible digital signature to verify the authenticity of a document. Once you add a digital signature, the document is automatically marked as final and cannot be edited. Mark a document as final to indicate to others that they are viewing a completed or final version of a document, and to prevent others from making unauthorized or inadvertent changes to the document. Word can be used to prepare a number of standard legal documents.

## What You Can Do

### Marking a Document As Final

- Mark a document as final to discourage others from editing it.
- A document marked as final opens in Read-only mode, and a Marked as Final icon  displays in the status bar.
- The ribbon does not display; instead an Information bar displays the message *MARKED AS FINAL: An author has marked this document as final to discourage editing.*
- You can click the Edit Anyway button on the Information bar to edit the document.
- The Mark as Final command is available from the Protect Documents drop-down menu on the Info tab in the Backstage view.
- To prohibit editing completely, set editing restrictions and password protection, as explained in Word, Lesson 29.

### WORDS TO KNOW

#### Digital certificate

An attachment for a file, macro, project, or e-mail message that vouches for its authenticity, provides secure encryption, or supplies a verifiable signature.

#### Digital signature

An electronic, encryption-based, secure stamp of authentication on a macro or document.

#### Invisible digital signature

A digital signature that is attached to a document but does not display in the document.

#### Signature line

A graphics object inserted in a document, on which a person can insert, type, or handwrite a digital signature.

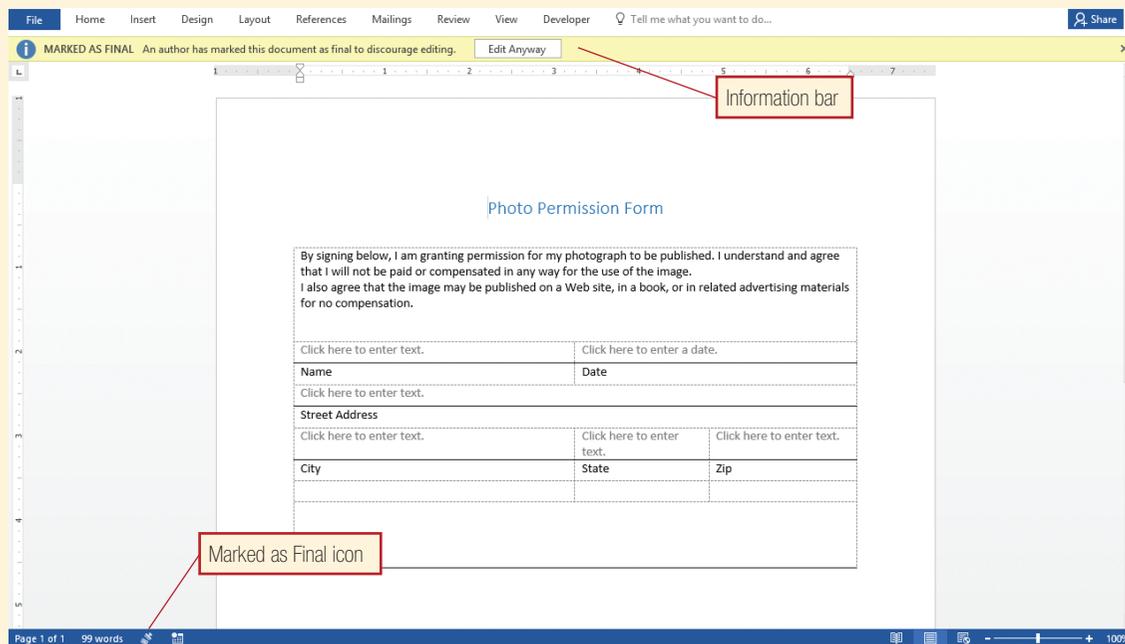
#### Visible digital signature

A digital signature that displays on a signature line in a document.

## Understanding Digital Signatures

- You can apply a **visible digital signature** or an **invisible digital signature** to a document.
- A **digital signature** can be used like a written signature to verify the authenticity of information.
- A digital signature indicates the following:
  - The signer is who he or she claims to be.
  - The content has not changed since the digital signature was applied.
  - The signer read and approved the document.
- A digital signature is created using a **digital certificate**, which can be obtained from an authorized vendor or from the internal security administrator responsible for your computer system.
- Windows usually creates a personal digital certificate—called a digital ID—for each user account.
- If you attempt to add a digital signature to a document, but you do not have a digital certificate, Word will display the Get a Digital ID dialog box, from which you can create your own personal digital certificate.

- A personal digital certificate is authorized only on the computer on which it is created.
- Once a digital signature is added, the document is marked as final, and the Signatures icon  displays in the status bar.

## Using a Visible Digital Signature

- A visible digital signature is similar to a standard signature line on a contract or other type of agreement.
- When you add a visible digital signature, Word inserts a **signature line** object into the document.
- You can use the options in the Signature Setup dialog box to add information about the signer, such as a name and a title, as well as instructions for the signer on how to add a digital signature.


- To sign the document, the signer opens the Sign dialog box in which he or she may type a signature or insert a digital image of a signature.
  - ✓ *If the signer is using a tablet PC, he or she may use a stylus to sign the document.*
- Once the digital signature is signed, the document is marked as final. If edits are made, the signature becomes invalid and is removed from the document.
- If there is a signature line in a document that has not been signed, the information bar displays a message that the document needs to be signed.

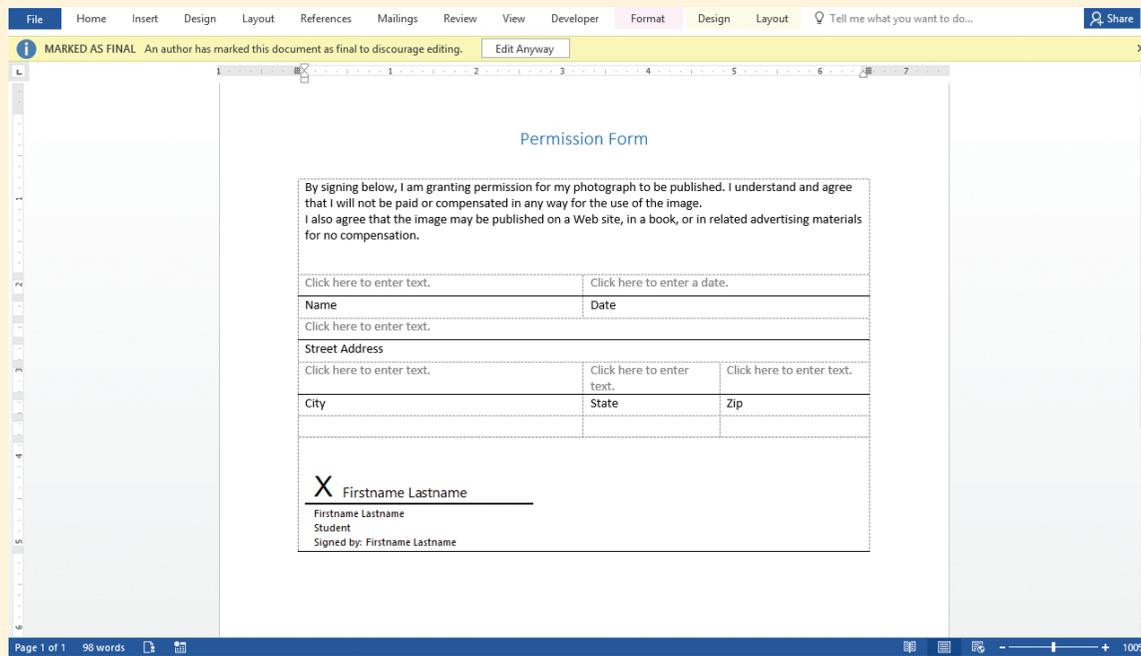

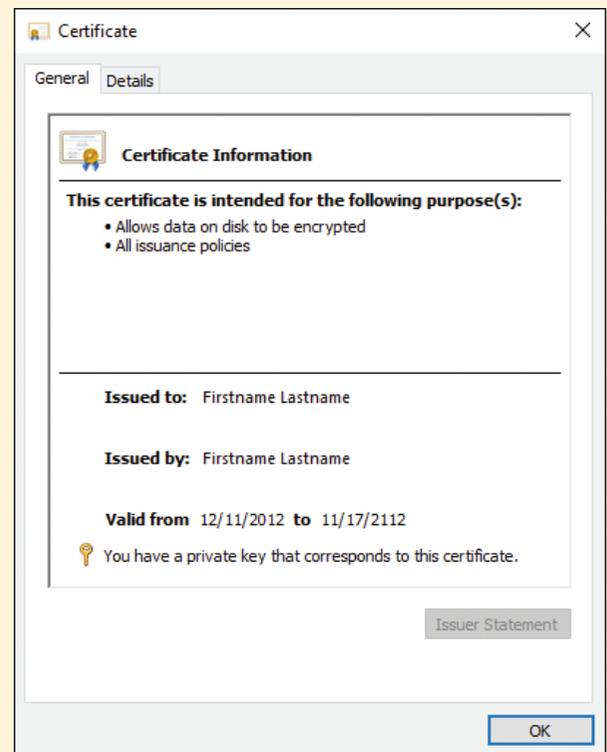

- If the status of a certificate cannot be verified, the signature is listed as having certificate issues.
- Some factors that might cause an invalid certificate or certificate issues include:
  - The content of the document has been changed since the signature was applied.
  - The document has been saved with a new name or in a new location.
  - The digital signature has a time limit, which has expired.
  - The certificate associated with the signature is unauthorized.
- You can view information about a signature in the Signature Details dialog box, including information about the certificate. You can also manually change a certificate from invalid to valid in the Signature Details dialog box, by adding it to a list of trusted certificates.

## Analyzing Legal Documents

## What You Can Do

---

### Inserting Comments

- Insert a **comment** to annotate text, communicate with readers, or to attach reminders or questions to a document.
- Comments are part of the revision marking features available with Word.
- The command for inserting a comment is in the Comments group on the Review tab of the ribbon.
- When you insert a comment, Word inserts **comment marks** around the word to the left of the current insertion point location, or around selected text.
- By default, in Print Layout view, each comment displays in a **balloon** in the **markup area** on the right side of the document page. The balloon connects to the comment marks by a dotted line.
- You can also choose to display comments in the **Reviewing pane**.
- In Draft view, comments display **inline**.
- You can also rest the mouse pointer over the comment marks to display the comment in a ScreenTip.
- Comment marks and comment balloons are color coded by reviewer.
- The full name of the reviewer who inserted the comment displays with the comment, along with the date or time the comment was inserted.
- When comments are displayed inline, only the initials of the reviewer and the comment number display.
- You can edit the text in a comment at any time.
- You can delete a single comment or you can delete all comments in a document.

#### Balloon

An area in which comment text or revisions are displayed.

#### Comment

A note attached to a document for reference.

#### Comment mark

Color-coded brackets that mark the location of a comment in a document.

#### Inline

Within the document text.

#### Markup area

A 3" wide strip along the right side of a document where comment and other revision balloons display.

#### Reviewing pane

A window where revisions and comments can be entered and displayed.



- In Word 2016, you can reply to a comment to deliver further information to a reviewer or offer your opinion on a proposed change.
- Use the Reply icon to the right of the reviewer name in a comment balloon to reply to a comment.
- A reply to a comment displays in the same comment balloon, indented below the original comment.
- The reply displays the name of the person who is responding to the original comment.
- You can change the current user name that displays in comments by specifying a new name and initials in the Word Options dialog box.

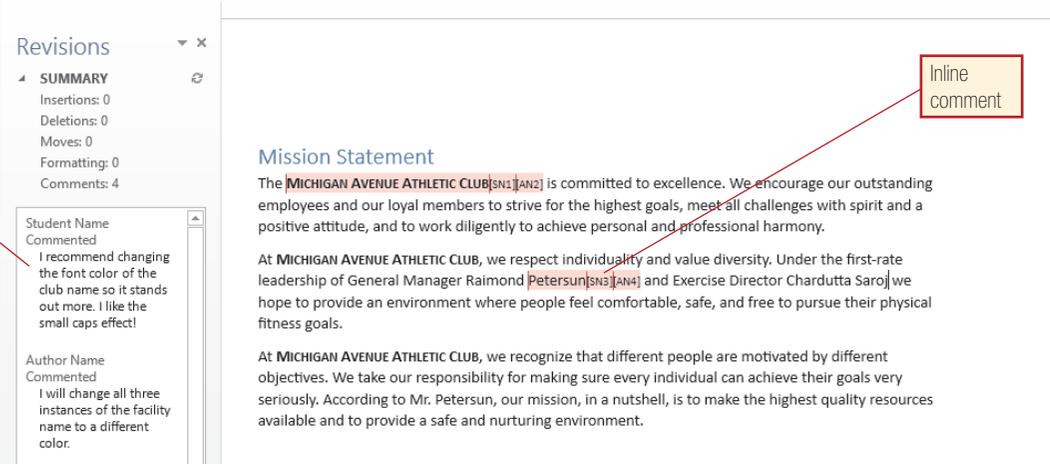



### WORDS TO KNOW

#### Add-ins

Application programs you download that perform specific tasks in Office.

#### Table of contents

A list of topics and subtopics in a document, usually accompanied by the page numbers where the topics begin and placed before the main body of the document.

**Software Skills** A table of contents is inserted at the beginning of a document to list headings and the page numbers where each heading starts. Word automatically generates the tables, and updates them when necessary. Manage your source information to make sure the references you use in your research are accurate and up-to-date.

- Word 2016 allows you to download a number of useful **add-ins** to improve your productivity, such as dictionaries for various languages, research tools, legal forms, and templates.
- Once you have downloaded an add-in, it is available for use in any document.

- Word automatically generates a bibliography, references, or works cited field from the source information when you select a style from the Bibliography gallery in the Citations & Bibliography group on the References tab of the ribbon.
  - ✓ *Inserting citations and generating a bibliography or reference page is covered in Lesson 22.*
- Open the Source Manager to view a list of sources used in the current document, and a master list of all sources.
  - In the Source Manager, you can edit or delete existing source information, or enter a new source.
  - You can also copy sources from the current document to the master list, or from the master list to the current document.
  - For example, to make a source in the Master List available for use in the current document, copy it from the Master List to the Current List.
  - Sources in the current list display in the Insert Citation gallery when you click the Insert Citation button in the Citations & Bibliography group on the References tab of the ribbon. Click the source to insert it into the current document.

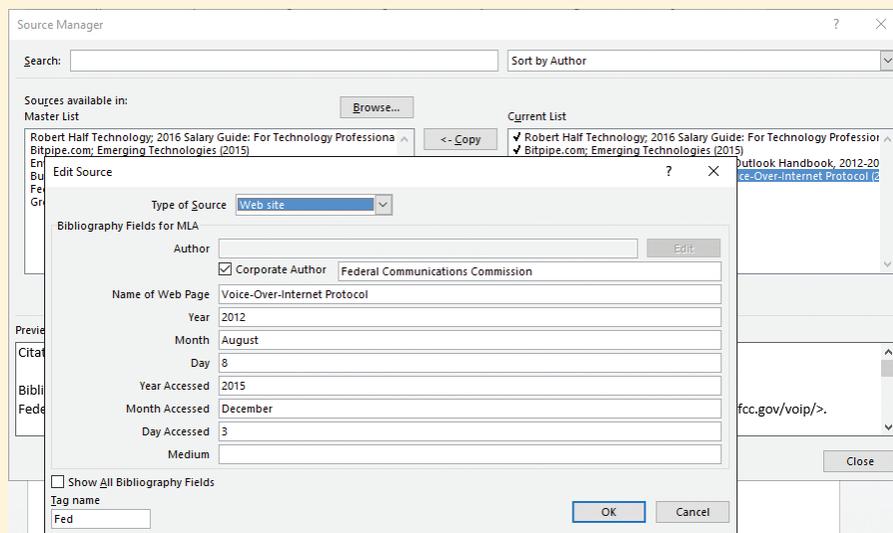

**Month Accessed: December**

- 8 Click OK, then click Yes in the confirmation dialog box to update the source information. In the Source Manager click Close.
- 9 In the document, in the first paragraph under the heading *Communications*, position the insertion point after the phrase *voice-over-Internet protocol* and type **, a service that converts your voice into a digital signal that can be carried on the Internet, .**
- 10 With the insertion point positioned at the end of the text you typed in step 9, on the References tab, in the Citations & Bibliography group, click the Style drop-down arrow and click MLA Seventh Edition, if necessary, then click the Insert Citation button , and click Federal Communications Commission.
- 11 Press **CTRL + END** to move the insertion point to the end of the document, press **CTRL + ENTER** to start a new page; then, on the References tab, in the Citations & Bibliography group, click the Bibliography button  and click References to insert a list of sources used in the document.
- 12 Save the changes to **W33Try\_xx**, and leave it open to use in the next Try It.

## Creating a Table of Contents

- Word generates a **table of contents** based on paragraphs formatted with heading level styles.
- If there are no heading levels assigned, Word cannot generate the table of contents.
- You can select from a list of built-in table of contents styles or use options in the Table of Contents dialog box to manually create a customized table.
- For example, you can select how many heading levels to include, whether or not to include page numbers, and, if so, to right-align them and use tab leaders.
- You can also choose to format the headings in the table of contents as hyperlinks. Press and hold **CTRL** and click the heading in the table to move the insertion point to that location in the document.
- You do not have to include all heading levels in the table of contents. For example, you may have paragraphs formatted with up to four heading levels, but select to include only two heading levels in the table of contents.

- 1 In the **W33Try\_xx** file, press **CTRL** + **HOME** to position the insertion point at the beginning of the document.
- 2 Click **References > Table of Contents**  to display the gallery of built-in styles.
- 3 In the gallery, under **Built-In**, click the **Automatic Table 1** style. Word inserts the table at the insertion point location.
- 4 On the **Quick Access Toolbar**, click the **Undo** button  to remove the table.
- 5 Click **References > Table of Contents**  to display the gallery of built-in styles, and click **Custom Table of Contents** to display the **Table of Contents** dialog box.
- 6 Under **General**, click the **Formats** drop-down arrow and click **Distinctive**.
- 7 Change the value in the **Show levels** box to **2**.
- 8 Click the **Tab leader** drop-down arrow and click the dotted line.
- 9 Click **OK** to insert the table.
- 10 Press and hold **CTRL** and click the heading **Salary Information** in the table of contents. Word moves the insertion point to that location.
- 11 Save the changes to **W33Try\_xx**, and leave it open to use in the next Try It.

## Updating a Table of Contents

- Update a table of contents if you add or remove headings, change heading levels, or add or remove pages.
- You have the option of updating the entire table, or updating page numbers only.
- You can use the **Add Text** button in the **Table of Contents** group on the **References** tab of the ribbon to mark a heading so it does not display in the table of contents, or to change the heading level of a paragraph so it does display.

**Try It!****Updating a Table of Contents**

- 1 In the **W33Try\_xx** file under the heading *Communications*, position the insertion point at the end of the first paragraph. Press **ENTER** and type **Developing Trends**.
- 2 Click **Home > Heading 2** to apply the Heading 2 style.
- 3 Position the insertion point at the beginning of the heading *Career Opportunities* and press **CTRL + ENTER** to insert a hard page break.
- 4 Click on the heading *Salary Information*, then, on the **References** tab, in the **Table of Contents** group, click the **Add Text** button .
- 5 Click **Do Not Show in Table of Contents**.
- 6 Scroll to the beginning of the document and click anywhere within the table of contents.
- 7 Click **References > Update Table** .

- 9 Close the **W33Try\_xx** document, saving changes, and exit Word.



- Insert a custom table of contents that uses the **Formal** style, shows page numbers right-aligned with a solid line tab leader, and shows 3 levels. Use page numbers instead of hyperlinks.
- Save the changes to the document.
- Insert a page break before the heading *Grafted Roses*.
- Insert a line before the last paragraph of the document (before the Index), type **Conclusion**, and format it as a **Heading 1** heading.
- Position the insertion point on a blank line after the table of contents and insert a bibliography using the **Words Cited** style.
- Select to not show the heading *Table of Contents* in the table of contents, and update the entire table.
- Apply the **Heading 1** style to the text *Table of Contents* on the first line of the document.
- Check and correct the spelling and grammar in the document.

**Software Skills** Use Word's Online Video command to locate video files to embed in Word documents. You can save any Word document as a Web page so it can be accessed on the Internet. Web pages can be opened and edited in Word. You can apply a colored or textured background to enhance the page for viewing on a screen. You can also add links that connect related documents to one another.

## What You Can Do

---

### Inserting an Online Video

- Word 2016 allows you to insert a video file right in a Word document, so you can view the video without having to leave Word.
- Use the Online Video command on the Insert tab to start the process of inserting a video.
- You can choose to search for a video file using the Bing search engine or YouTube, or you can paste the code required to embed a video in the document from a video you are viewing online.
- An embedded video file can be formatted the same way you format a picture. You can adjust the size, change the wrap option, or apply picture styles.

### Words to Know

#### Browser

Software designed for locating and viewing information stored on the Web.

#### Fill effect

A texture, shading, picture, or pattern used as a background.

#### Gradient

A gradual transition from one color to another.

#### HTML

Hypertext Markup Language, a type of encoding that tells a Web browser how to format and display text and graphical information.

#### Internet

A worldwide network of computers.

#### Internet Service Provider (ISP)

A company that provides access to the Internet for a fee.

#### Link

Text or graphics linked to a destination file or location. Click the link to jump to the destination.

**Texture**

A repeating graphic that gives a surface appearance such as stone, wood, or cloth.

**Web**

Short for World Wide Web. An interconnected network of Internet servers and pages of information in HTML format.

**Web page**

A document stored on the Web.

**Web page title**

The text that displays in the title bar or tab when a Web page is viewed in a Web browser.

**Web server**

A computer connected to the Internet used to store Web page documents.

**Web site**

A set of linked Web pages relating to the same topic.

**Understanding Web Pages**

- You can use the **Internet** to communicate via e-mail and social media services, to locate product information and support, to perform job searches, to find reference material, to shop, to review stock quotes, to make travel arrangements, and to play games.
- Much of the information you find on the Internet is contained on Web pages.
- **Web pages** are documents that are stored on a **Web server** so they can be accessed on the **Web** by anyone with a computer, an Internet connection, and Web **browser** software.
- Microsoft Office 2016 comes with the Internet Explorer Web browser, although your computer may be set up to use a different browser, such as Firefox, Safari, or Google Chrome. Windows 10 includes the new Microsoft Edge browser.
- For a fee, **Internet Service Providers (ISPs)** provide you with an e-mail account and Internet access that allows your browser to connect to Web resources.
- Web page files must be in a file format that is compatible with the Web and browser software. Most files on the Web are in some form of **HTML**, which stands for Hypertext Markup Language. Some are in PDF format. Other file formats may also be used.
- Web pages are usually linked into **Web sites** that have a common topic. For example, [www.whitehouse.gov](http://www.whitehouse.gov) is a Web site about the White House.

## Saving a Word Document As a Web Page

- You can save a Word document as a Web page so it can be stored on a Web server and viewed online.
- When you save a document as a Web page, you can choose from three Web page formats:
  - Single File Web Page. Saves a Web page and all associated text and graphics in a single file in MHTML format. This is the default option. These pages have an .mht or .mhtml extension.
  - Web Page. Saves the document in HTML format. These pages use .htm or .html extensions. Associated graphics files such as pictures are stored in a separate folder that is linked to the HTML file. The folder has the same name as the HTML file, followed by an underscore and the word files, like this: Filename\_files.
    - ✓ Use caution when moving or renaming the graphics files or the folder they are stored in. If Word cannot locate the files, the page will display without graphics elements.
  - Web Page, Filtered. Saves a file in HTML format without Microsoft Office tags. This reduces the file size, but limits some functionality for editing the file. These pages use .htm or .html extensions.
    - ✓ This option is recommended for advanced users only.
- No matter which Web page format you choose, you can change the **Web page title** to a descriptive word or phrase that will help the viewer know what the page displays.
- You can save a Web page in any storage location; in order to be available to viewers on the Web, it must be uploaded and stored on a Web server.
- When you save the file as a Web page, Word displays a list of features that are not compatible with the selected Web page format in the Compatibility Checker dialog box.
- After a document has been saved as a Web page, it displays in Word in Web Layout view.
  - ✓ You can also switch to Web Layout view by clicking the Web Layout button in the Views group on the View tab of the ribbon or from the View buttons on the status bar.
- Web Layout view displays documents in Word as they will look on the Web. The text wraps to fit the window rather than the page, and graphics are positioned as they would be in a Web browser.
- You may have to adjust design features that look good in a Word document so that they look good on a Web page. For example, you may have to adjust the width of tables or the position of graphics.

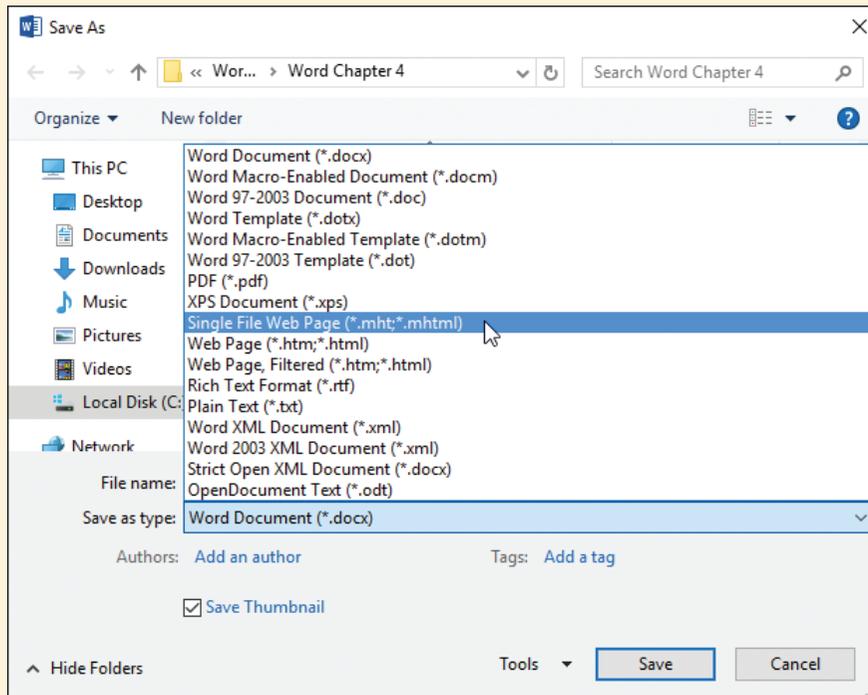

**Opening a Web Page Document in Word**

- In Word, you can open and save Web pages that were saved in any of the three Word Web options: Single File Web Page, Web Page, and Web Page, Filtered:
- Open any of these types of Web pages in Word the same way you open a regular Word document.
- When you save the document, it remains in its original format unless you save in a different format.
- If you double-click a Web page from a Windows file listing, it opens in your Web browser, not in Word.

**Try It!****Opening a Web Page in Word (within Word)**

- 1 In Word, click File > Open.
- 2 In the Recent Documents list, click **W34TryB\_xx.mht** to open the document in Word.
- 3 Close Word without saving changes.

**Applying a Background**

- By default, Word documents—including Web pages—have a plain white background.
- Add visual interest or create an effect by applying a color, pattern, **fill effect**, or picture to a document background.
- One of the fill effects available is **gradient**, which is a gradual blend from one color to another.
- Another effect is **texture**. Textures are small graphic files that repeat as many times as needed to fill the background; they resemble various materials like wood, cloth, and stone.
- You can apply a background to any Word document, not just a Web page.

**Try It!****Applying a Background**

- 1 In the **W34TryB\_xx.mht** file, click Design > Page Color .
- 2 Click Blue, Accent 1, Lighter 80%.
- 3 Click Design > Page Color .
- 4 Click Fill Effects. The Fill Effects dialog box opens.
- 5 Click the Gradient tab, if necessary, and then click Two colors.
- 6 Open the Color 1 drop-down list and click Blue, Accent 1, Lighter 80%.
- 7 Open the Color 2 drop-down list and click Orange, Accent 2, Lighter 80%.
- 8 In the Shading styles section, click Diagonal down.
- 9 Click OK.
- 10 Click Design > Page Color  > Fill Effects.
- 11 Click the Texture tab.
- 12 Click the first texture in the first row.
- 13 Click OK.
- 14 Save the changes to **W34TryB\_xx.mht**, and leave it open to use in the next Try It.

**Creating Links**

- **Links** can be used to connect locations within a single document, to connect two documents, or to connect a document to a Web page or e-mail address.
- Links can be created in any type of Word document, not just in Web page documents.
- When you format text as a link, Word automatically applies the Hyperlink style, which by default uses a blue font and a solid underline, but may be different depending on the current theme.
- Once you click the link, the font color changes to indicate that the link has been used.
- A link can point to a Web page or document (or any other type of file) in general, or to a specific heading or bookmark within that document.

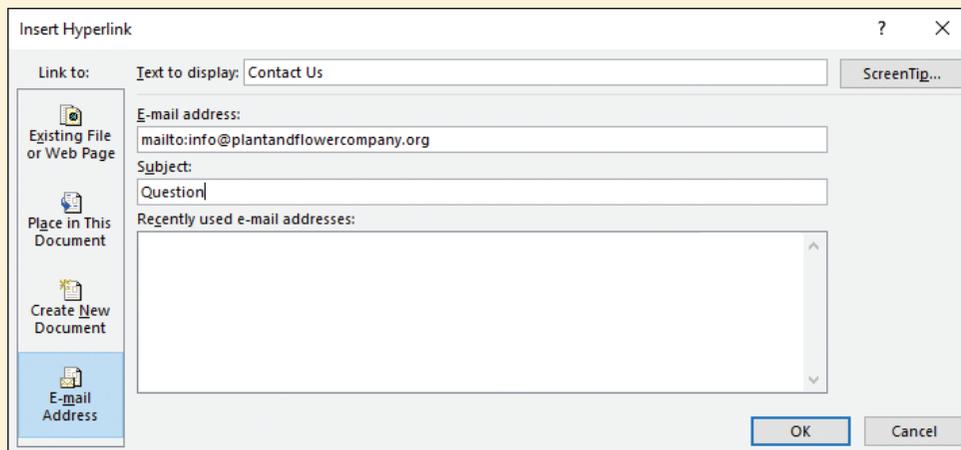

## Testing Links

- By default, in Word documents you must press **CTRL** and click the link in order to go to the link destination. This helps avoid accidental access.
- When you press **CTRL** and click a link to a Web page, the document opens in your Web browser program.
- When you press **CTRL** and click a link to an e-mail address, Word starts your e-mail program and displays a new e-mail message. The address and subject are filled in with the link information.
- If you want, you can change the setting so that you don't have to press **CTRL**.

### Zebra!

Zebra travel in large herds, and often mingle with other wildlife, such as wildebeest. The most distinguishing feature of zebra is, of course, the black and white stripes. ### WORDS TO KNOW

#### Bookmark

In Firefox and some other Web browsers, a saved link to a Web page. Also called *favorite*.

#### Domain name

The name that identifies a Web site.

#### Favorite

In Internet Explorer and some other Web browsers, a saved link to a Web page. Also called *bookmark*.

#### Home page

The default page that appears when you open Internet Explorer (or another Web browser, such as Microsoft Edge).

#### Navigation bar

A list of sections or pages that you can quickly jump to from the current Web page. Typically a navigation bar is consistent across all the pages on a site.

**Software Skills** Because so much information is available on the Web, it is important to know how to look up information, and how to navigate Web sites. You should also know how to bookmark pages that you find for later viewing.

## What You Can Learn

---

### Viewing a Web Page in a Browser

- You learned in Lesson 34 that one way to open a Web page in a browser is to double-click it in File Explorer.
- A more common way to display a Web page is to use your browser to go to a **uniform resource locator (URL)**, which is the address of the file stored online.
- You use the Address bar in the browser to enter URL addresses.
- The main parts of a URL are:
  - The **protocol**, which tells the browser software the type of server where the page is stored. Web page servers use the `http:` or `https:` protocol.
  - The **domain name** (sometimes called a host name), which identifies the company or organization to whom the Web site is registered. `microsoft.com`, `whitehouse.gov`, and `harvard.edu` are all domain names.
  - The **path**, which identifies the specific Web page or document to open.
- The end of the domain name—the last dot followed by two to four letters—is called the *top-level domain*. It helps identify the type or location of the company or organization.

- When you start your browser, your **Home page** displays. This is the page that has been set as the default starting place for your Web browsing. You may use links on your Home page to view other Web pages.
- As you move from page to page on the Internet, you can use the browser's Back button to return to a previous page.
- After the Back button has been clicked, a Forward button becomes available. Clicking it returns you to the page you were on before you clicked Back.
- The Home button returns you to your Home page.
- If your browser is set to use tabbed browsing, clicking a link on a Web page may open a new tab rather than display a new page in the existing tab.

## Navigating a Web Site

- Most Web sites consist of multiple linked pages, with a navigation system of some type tying them together.
- Typically a **navigation bar** appears either along the left side of the page or across the top. Some Web sites use both. A navigation bar lists subject headings. Clicking a subject will either open another page on that theme, or will open a menu, depending on the construction of the site.
- To move to a different page within the same site, click a link within the navigation bar.

## Locating Information Online

- Almost every topic you might want to know about can be found somewhere on the Internet. To find it, you can use a **search engine**. A search engine looks up the keywords you specify in a large index of Web sites, and provides links to relevant content on a Search Results page.
- There are thousands of search engines, but a few large ones dominate. They include:
  - Google: [www.google.com](http://www.google.com)
  - Bing: [www.bing.com](http://www.bing.com)
  - Yahoo: [www.yahoo.com](http://www.yahoo.com)

- Depending on the browser, a saved link to a page might be called a **favorite** (Internet Explorer) or a **bookmark** (Firefox and some other applications).

**Evaluating the Usefulness of Online Information**

- Depending on the type of information desired, different sites may be appropriate.
- For current news stories, sites that aggregate (collect) news stories, such as news.google.com, produce good results.
- For general knowledge, an encyclopedia may be useful, such as <http://www.britannica.com/>.
- Wikipedia is a well-known public information collection, like an encyclopedia. However, since it is maintained and updated by the public, it is not authoritative.
- General Web searches produce a mixed bag of results. Some sites are authoritative, and others are not. Here are some criteria for determining the reliability of a site:
  - Is it professionally designed and maintained?
  - Is it up to date?
  - Is it run by a well-known company?
  - Is it sponsored by a neutral company with no profit to be made by skewing the information?
  - Does it cite the sources from which the information has been taken, if the site owner did not do the original research?
- You can also use the top-level domain to help you determine if a Web site is a good and accurate source for information.

- For example, .gov indicates a government Web site and .edu indicates an educational institution. Both are generally reliable sources.
- The .com domain indicates a commercial business, so you might assume the information on the site is intended to support or promote the business in order to make money.
- The .org domain indicates a nonprofit business, so you might assume the information on the site is intended to promote a point of view or to encourage fundraising.

**Solving Problems Using the Web**

- Many sources of problem-solving and troubleshooting information are available on the Web.
- For example:
  - Computer troubleshooting is available at sites such as [www.cnet.com](http://www.cnet.com).
  - Medical self-diagnosis help is available at sites such as [www.webmd.com](http://www.webmd.com).
  - Consumer advice is available at sites such as [www.epinions.com](http://www.epinions.com).
  - Automotive repair help is available at sites such as [www.2carpros.com](http://www.2carpros.com).
- Like other information, these sites should be evaluated carefully for credibility before taking the advice at face value. This is especially true for sites that dispense medical and safety information.

#### Cross-Functional Team Project

You work in the IT department for Tech for All. Company management has recently approached the IT department to research the feasibility of equipping the three-member sales force with new tablet computers. They are currently using older laptops running the Microsoft Vista operating system. The company has a limited budget for the upgrade that will have to cover training time as well as purchasing costs.

In this project, you will work with a team of three other students to determine what kind of tablets will best suit the sales force and recommend a tablet option that will meet budget requirements.

#### DIRECTIONS

##### Create a Form

1. Create a form to gather the following information from your team members. You may use a table if desired to align form fields.
  - Name (Rich Text Content Control)
  - Department (Drop-Down List Content Control with options for Administration, Sales, and IT)
  - Best day to meet (Check Box Content Controls for days of the week)
2. Add a statement below the form that the team member will sign, indicating that he or she understands he or she will be dealing with confidential company information and agrees not to divulge any privileged information to employees other than his or her teammates.
3. Insert a signature line using the signer name *Firstname Lastname* that each team member can sign after filling out the form.
4. Save the form as **WCT04A\_xx**, and restrict editing to filling out the form.
5. Save the form to your OneDrive so that all team members will be able to download a copy, and then test the form by opening it in Word from OneDrive, filling out the form, and saving it with the name **WCT04B\_xx**. Then insert a digital signature in the signature line box, save changes, and close the form.

##### Create the IT Project Document

1. Assign your team member roles:
  - One team member should be from the Sales Department. This team member should be in charge of creating a list of features the new tablets should have.
  - One team member should be from the IT Department. This team member should review the feature list and do research online to locate tablets that might meet many or all of the Sales Department's requirements. He or she should prepare a table comparing features and prices.
  - One team member should be from Administration. This team member should review the tablets identified by the IT team member and determine which tablets will fit in the upgrade budget for new equipment while still allowing money for training. The upgrade budget is \$3,000. Training costs are figured at \$75/hour to cover the time of the IT Department trainer. The Administration team member should calculate the costs for the three tablets, plus sales tax in your area, and then determine how much money is left for training and how many training hours that amount will cover.
  - Your role as a member of the IT Department is to evaluate all the information provided by your teammates and make a final recommendation for management. You should be prepared to provide sound reasons for eliminating systems from consideration and for your final recommendation. You may need to do additional research on the tablet you think best.

2. As a team, brainstorm together to come up with a list of the types of information each team member should supply, and how that information could be presented. In this meeting, for instance, you may decide on what tablet features to compare (operating system, processor, storage, and price, for example) and how to organize the cost and training information.
3. Each team member should create a document that fulfills his or her responsibilities. Team members may conduct research on the Web and, if desired, copy pictures from the Web to their documents, providing a proper source line to indicate where the images were found.
4. As team leader, your first job is to combine the three documents into a single document named **WCT04C\_xx** that you will present to company management, with your recommendations as the final section. Insert the names of all team members in the footer and today's date.
5. Have all team members read the final document and supply comments as necessary to point out necessary changes. You may reply to these comments and mark them as complete, or delete them after you have addressed the issues.
6. Inspect the document and remove any document properties and personal information. Check compatibility.
7. When you are satisfied that the document is complete, apply the password **WCT04C\_xx** to encrypt the document, then mark it as final and e-mail it as an attachment to your instructor.

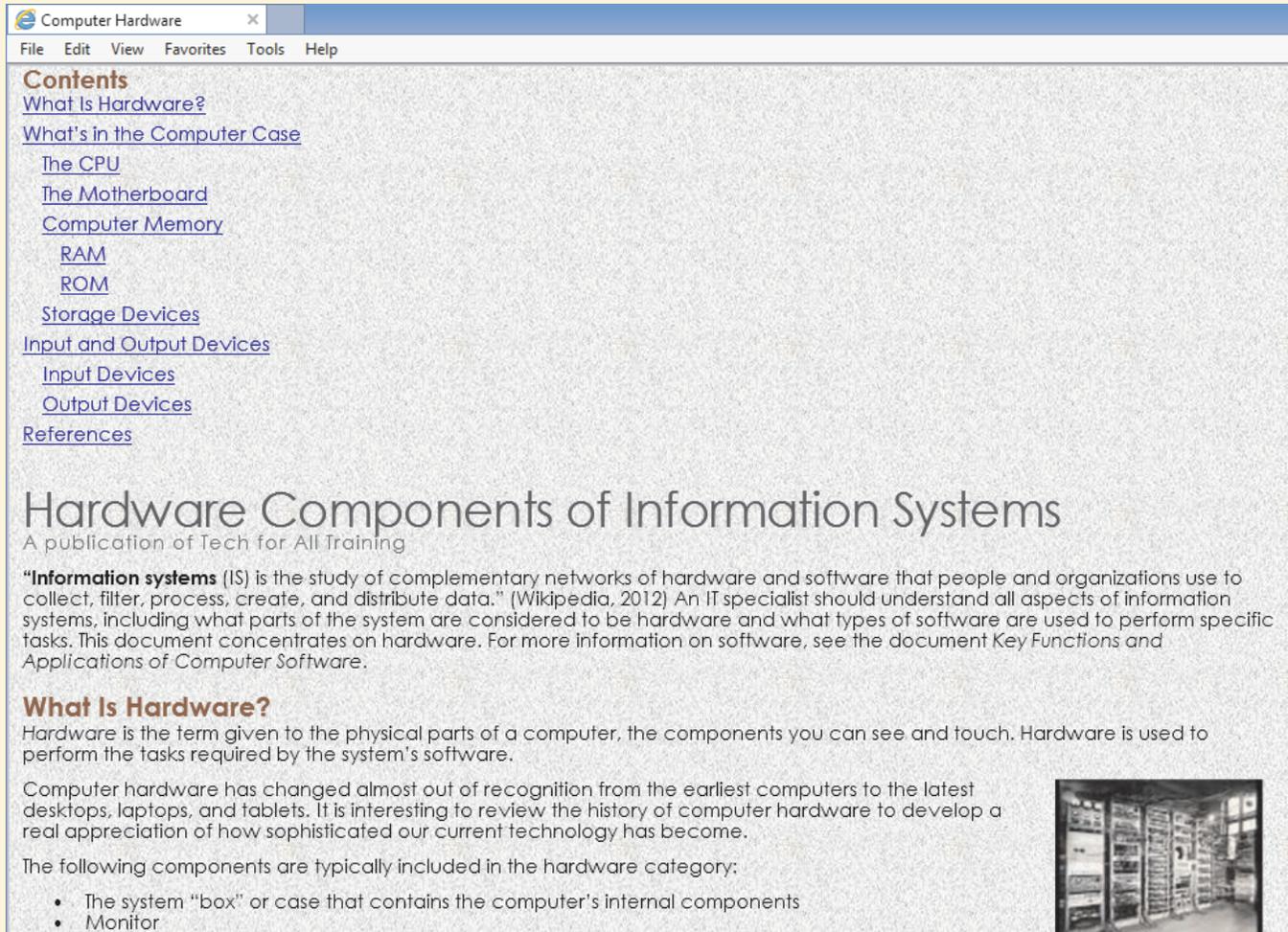

Then remove the Computer History Museum source from the Current List.
4. Save your changes so far. E-mail the document as an attachment to a fellow student and ask him or her to review the changes you made in response to comments. Ask him or her to comment on any further changes that might need to be made to the document.
  5. Press **CTRL** + **HOME** to move the insertion point to the top of the document.
  6. Click **Insert > Blank Page**  to insert a blank page before the first page of the document.
  7. Click **References > Table of Contents**  > **Automatic Table 1**.
  8. Press **CTRL** + **END** and then click **References > Bibliography**  > **References**.
  9. Update the table of contents to include the References heading.
  10. Make any changes suggested by your classmate, then inspect the document and remove all comments and document properties.
  11. Save the current version of the document as **WPB04B\_xx**.
  12. Save the document as a Single File Web Page named **WPB04C\_xx**, with the page title **Computer Hardware**.
  13. Remove the page break on the Web page, and then apply the **Newsprint** fill effect to the page background.

## Hardware Components of Information Systems

A publication of Tech for All Training

**"Information systems (IS)** is the study of complementary networks of hardware and software that people and organizations use to collect, filter, process, create, and distribute data." (Wikipedia, 2012) An IT specialist should understand all aspects of information systems, including what parts of the system are considered to be hardware and what types of software are used to perform specific tasks. This document concentrates on hardware. For more information on software, see the document *Key Functions and Applications of Computer Software*.

### What Is Hardware?

Hardware is the term given to the physical parts of a computer, the components you can see and touch. Hardware is used to perform the tasks required by the system's software.

Computer hardware has changed almost out of recognition from the earliest computers to the latest desktops, laptops, and tablets. It is interesting to review the history of computer hardware to develop a real appreciation of how sophisticated our current technology has become.

The following components are typically included in the hardware category:

- The system "box" or case that contains the computer's internal components
- Monitor
